VEHICLE USE



GOTS is the worldwide leading textile processing standard for organic fibres. This standard stipulates requirements throughout the supply chain for both ecological and labour conditions in textile and apparel manufacturing.



ETHICAL TRADING

Clad Safety only work with accredited factories which have been independently audited and approved for their ethical working practices. We endorse the ethical policies set out by the Ethical Trade Initiative base code and routinely check that our suppliers conform to the same standards.





Recycled Products

We are investing time and knowledge into educating both the Clad Safety Team and our customers on the wide range of recycled Workwear, Footwear and PPE available to buy.



The National Hard Hat **Recycling Scheme** diverts safety helmets into a dedicated waste processing facility, ensuring all hard hat waste is fully recycled.



High visibility workwear that is constructed from fabrics derived either from recycled post-consumer clothing or recycled plastic bottles and conforms to ISO 20471





Safety footwear made from 100% recycled PET and **POLY-GREEN** recycled polyurethane
